Update from Area 45:

Dawn asked Wendy from Area 45 to come to the front of the room and share what is going on inside the GSO and local Area 45.

Wendy shared on how 59% of GSO operating cost comes from the contributions from the groups. Right now the contributions are down which in turn makes it harder for the General Service Office to do their jobs of helping the next suffering alcoholic. Wendy asked that we all go back to our groups and ask to see if our homegroups had prudent reserves to send some of the money to the GSO.

Next she spoke about the accessibility and GrapeVine alongside of PI/CPC how these sections of Alcoholic Anonymous are making the Plain Language Big Book possible. There had been discussion Wendy mentioned about changing the 12 Steps into plain language however that would be too close to changing the steps which is not something as a whole the body was comfortable doing. Therefore, the 12 Steps will remain in the same language they are in now. With the change of the book it was noticed that the average person coming into Alcoholic Anonymous has the reading level of a third grader. Changing the book into the plain language will give more people a chance to achieve sobriety.

How this new book is going to work is actually very interesting. One the page to the left will be the old native language of the Big Book and on the page to the right will be the native language changed into the plain language.

This is going to allow people coming into Alcoholic Anonymous a chance to be able to read the book without help, start the steps if there is no sponsor around, and a way out of their old lives.

Lastly, it talked about anonymity and social media. There is currently a poll and/or questionnaire for the newer 'younger' members to find out ways to keep the anonymity of the members safe.

4. Opening Prayer:

Julia conducted the Opening Prayer; the 12th Step Prayer: **“Dear God,my spiritual awakening continues to unfold. The help I have received I shall pass on & give to others, both in & out of the Fellowship. For this opportunity I am grateful. I pray most humbly to continue walking day by day. On the road of spiritual progress. I pray for the inner strength & wisdom to practice the principles of this way of life in all I do & say. I need You, my friends, & the program every hour of every day. This is a better way to live.”**

5. Tradition Reading: the long form of the Tradition that corresponds to the month

Robbie read the long form of the Tradition that corresponds to the month; **6th Tradition:** *“ Our groups ought never endorse, finance or lend our name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose. Six—Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.”*

Phone Chair Report - June 2023

Volunteers answered 136 calls in May,
- highest number of calls this year and attributed to two repeat callers:

Male caller is 20 yrs sober, homebound, wheelchair, no cell phone. He has received several call backs from men in the program. He was mailed a list of phone/dial-in meetings, but continues to call just to talk.

Female repeat caller is always looking for a ride, uses fake names and knows when to call back at shift changes to get another volunteer to try again. She sometimes calls up to 5 times a day, angry and manipulative. We block that number, she gets a new number.
